INTRODUCTION

Grace and Peace Missionary Fellowship was founded in 1985 when Bill Rumble began taking short-term mission trips to Haiti. Bill traveled back and forth to Haiti from 1985 until 1996. In 1998, the Rumble family went to the Dominican Republic (The DR shares the Island of Hispaniola with Haiti) to see what the needs were. We discovered that there were Haitian living there because Barahona is only 1 hour from the Haiti/Dominican Republic border. In July of 1999, the Rumples were called into full-time missionary work and began preparations to move to the mission field. On January 27, 2000, Bill moved his family to Barahona in the Dominican Republic to develop a Ministry Center.

PRESENT PROGRAMS

1. **EVANGELISM:** We evangelize through every program we have set up and our team goes into the local hospital and prison to share the Gospel. When American teams come down, we go into one area for the week to build relationships and to teach them about the Lord's saving grace. When they make a commitment, we hold discipling classes and then plug them into a local church.
2. **CHILDREN'S PROGRAM:** We have 5 Children's Programs where 300 children are enrolled. They meet on the weekends and our main focus is memorizing the Word of God.
3. **WATER PROJECT:** In the past 26 years, we delivered over 11 million gallons of water. Presently, we no longer need to deliver water as the Dominican Government finished a large aqueduct project and now provides water to the poor in the areas we were delivering to. We drilled a 2nd well which provides water directly into the homes of 120 houses surrounding the Mission House.
4. **MOBILE MEDICINE:** G&P conducts free medical clinics treating as many as 1500 people in one given area. We evangelize and share the Word of God with each patient. We provide health education while the patients wait, introducing them to ways to improve their health. U.S. doctors and dentists volunteer for short-term mission trips to help treat the people in special clinics for a week at a time.
5. **WIDOW MINISTRY:** We take care of 100 widows. Each widow is sponsored at \$55 per month, which provides food, medical care and clothing.
6. **FARMING PROJECT—** We own a 45-acre farm where we sharecrop with many of the Nationals.
7. **THE BUILDING PROJECT:** We encourage teams to come and help with several on-going building projects, i.e., churches, cisterns, widow house maintenance, etc.

THE VISION OF GRACE AND PEACE

1. G&P will continue evangelizing and building relationships with the Dominicans. We want to help the local church grow as much as possible as we plug each new commitment for the Lord into them.
2. To host medical, dental and surgical teams who will donate one week of their time to conduct specialized clinics in Barahona and the surrounding areas. To have special programs set up in area churches that will reach the children with diabetes, the pregnant mothers as well as asthmatics.
3. We provide a meal of protein at each of our Children's Programs along with teaching them the Word of God. It's our goal to have a fully functional school one day where the children are taught Christian values as well as educating them as a private institution.
4. To grow what food is necessary for our children's program, widow program and for special circumstances in the medical clinic on the farm we own. This farm will allow us to be more self-sufficient.
5. In the Widow Program, we are helping 100 widows/widowers. It is our goal to maintain this ministry with excellence as we provide for their daily needs. We will be adding more widows as the Lord provides.
6. As our facility is now complete, we have opened it up for other missionaries in Haiti and on the island to come and stay for free to get rest. Our vision also includes housing as many short-term mission teams, missionary interns, doctors, dentists, surgeons and their families as possible.

FINANCIAL MATTERS

The cost of your short-term missions trip will be set by your Team Leader and will include current airfare rates, ground cover (ministry expenses, room and board, in-country travel, etc.) and project donations. All teams must fly into Santo Domingo, Dominican Republic (SDQ is the airport identifier).

FOR TEAM LEADERS ONLY—Grace and Peace requires all Team Leaders to deposit half of the total ground cover as well as work project monies 30 days before your group is scheduled to arrive with the balance due 14 days before your arrival. No refunds will be issued within 14 days of your scheduled trip. Please make all checks payable to: Grace and Peace Missionary Fellowship, 2055 Pleasant Valley Road, Niles, Ohio 44446.

GROUND COVER: Ground cover is room and board, and local transportation that coincides with the schedule set for your team. The cost for your time in the Dominican from Saturday to Saturday is \$800 per person to cover your room and board. For teams of 1-9 members, there is a one-time \$250 charge for transportation in the large bus to and from the airport. Each team will need to cover all interpreters for their week at \$200 per interpreter. Please contact us by email at graceandpeacemissfell@gmail.com for ground cover costs if your trip is more than 8 days. The day you arrive in Santo Domingo and the day you depart count as days when we calculate your ground cover as they are the costliest of all days because of the long ride you have to/from our Mission House.

IMPORTANT THINGS TO REMEMBER:

1. Your arrival flight should arrive before 3:00 p.m. Your departure flight **cannot** leave Santo Domingo before 1:00 p.m. An additional fee of \$150 each way will be assessed if you are unable to arrive and depart within these times.
2. All food & drinks outside the Mission House will be at the cost of each team member. **Optional: \$16 per person to eat pizza in town.**
3. Additional monies may be raised for a team's work project.
4. Evangelism teams need to bring 5 bibles per each team member.
5. Medical/dental teams need to submit monies so we can purchase medicines.^[SEP]
6. Interpreters for your team will be \$200 for each one needed. These monies must be submitted under the ground cover and project money guidelines.

During your time at our mission house, we will be selling Larimar jewelry. Larimar is one of the rarest gemstones in the world and it is mined only in one town in the entire world, Barahona, the very town Grace and Peace is located. All proceeds are used to meet the extra needs that arise in our Widow Program.

Many times prospective team members email G & P asking if they can bring anything extra for the mission. As well, if short-term mission team members, including work teams, evangelism teams as well as medical/dental teams, would please consider bringing a few of these items, we would be greatly blessed. You can feel free to purchase some items at the Dollar Store, as they have many great quality products. Please see special note on batteries:

1. School Supplies: notebooks, pencils, pens, markers, colored pencils, erasers (Most Important)
2. Small gadget-type toys – Unisex, please, if possible

VERY IMPORTANT INFORMATION

It is a requirement of Grace and Peace Missionary Fellowship that all short-term Missions Teams Members have Medical Insurance for your trip. If you do not have Medical Insurance, please go to one of these sites and purchase insurance for your trip. You will not be permitted to come without Medical Insurance and this site offers it at a very affordable price.

Check with your Health Insurance Company to confirm you are covered for international travel to the Dominican Republic, otherwise you will need to purchase short term trip medical insurance coverage and provide a copy of this with your forms.

YOUR SHORT-TERM MISSIONS TRIP

The most important part of your trip here is that you have opened yourself up to an opportunity to grow spiritually by dedicating your time to serve God. Here at Grace & Peace, we appreciate that you have come to help the Mission complete a project, participate in the regular day-to-day ministry programs, conduct a medical clinic or to evangelize.

While on your mission's trip here, we ask that you adhere to the schedule provided, participate in team activities, and also work to serve others. As part of a mission's team, you will need to be flexible to accept the disappointments as well as the joys. If things get off course, look for God's hand rather than reasons to complain. There are many things here in the Dominican Republic that takes a whole day to accomplish that might be accomplished in one hour in America. It may take flexibility and a lot of grace, but always model cooperation, servanthood and love in relationships with teammates, team leaders and The Mission in general.

Please remember: While you are here, be cautious about how much fresh fruits and juices you consume. You can eat and drink to your heart's content, but if this is not how you normally eat in America, it may become a problem for you here mixed with the heat. We need you to stay healthy!!!

During your stay here in the DR, please let us know if you need anything.

PACKING FOR YOUR TRIP

PLEASE bring luggage you don't mind damaging and pack light.

NECESSARY ITEMS FOR YOUR TRIP:

Personal Medical Kit (Bandages, aspirin, calamine lotion, antibiotic ointment, meds for diarrhea, sunscreen)

Deep Woods Off Mosquito Repellant – most others, including musk oil, lemon oil as well as all other natural repellants **WILL NOT PROTECT YOU** enough.

Antibacterial gel and/or Aloe Gel

One roll of toilet tissue per person

Documents: passport and airplane tickets

Comfortable shoes (Do not attempt to break in new shoes in the D.R.)

Personal Toiletries

Towels and washcloths – **THIS IS VERY IMPORTANT**

Bible

Camera

Snacks in Ziplocs at all times or you may be inviting unintentional guests!

Water bottle - IMPORTANT—(Refillable plastic kind)

Journal, Money Belt and Important phone numbers

Ladies: Dresses, skirts, short-sleeved shirts. No skinny-strapped tank tops at any ministry function, as it is offensive to their culture. Sleeveless tops are okay at ministry functions. Also, sleeveless tops and modest shorts are fine at the Ministry Center. No short shorts at anytime.

One-piece bathing suit must be worn to the beach. If you do not comply with this, you will not be permitted to go.

Men: Light slacks and shorts.

Medical personnel: Medical clothing.

Work Teams: Work clothes, work boots and gloves.

DO NOT BRING prized possessions on your mission's trip.

SAMPLE SCHEDULE

When you are scheduled on a special loading crew, i.e., loading lunches in the truck, please be sensitive in adhering to that schedule so no undue pressure is added to the other team members.

Also, at the beginning/end of each day, there will be a 30-minute devotional time.

Here is a sample schedule:

7:00 am: Breakfast will be served.

7:30 am: Short Devotional. (15-30 minutes). Please come to devotions prepared to start your day. A short period of time (5-10 minutes) will be allowed before we board the bus to tie up any loose ends in preparing for your service.

8:00 am: Prepare to board the bus. Bill will direct team members participating in construction where they are needed. All other team members will work with Karen in preparation for that day's ministry programs. Evangelism Teams will be instructed as to where they will be witnessing that day.

12:30 Noon: Lunch is served.

2:00 pm: Work resumes. Evangelism resumes.

4:30 pm: Supper is served. Clean-up crew.

Evenings are left open for fellowship at the mission house.

The Team Leader will announce devotional time.

CODE OF CONDUCT

1. No team member can leave the team or main group unless the Team Leader is notified and in agreement.
2. Any team member who does not abide by the Code of Conduct or who leaves the compound after dark without permission will be asked to leave. Arrangements will be made at your expense to return to the States.
3. Grace and Peace Missionary Fellowship's property or any property that doesn't belong to you personally must be treated with care and respect at all times. If you break something accidentally, please notify us. If you do not notify us, your team will be required to pay for whatever was damaged or broken.
4. All Mission House guests are asked to please not venture anywhere in the back of the house (3rd Floor) as this is Bill and Karen's private quarters.
5. Attn: Women and young ladies, proper attire for the beach is a 1-piece swimming suit. If you do not want to buy one, you will have to wear shorts that fall mid-thigh and a dark colored wide-strapped tank top. Under no circumstances are 2-piece bathing suits allowed. If you have a tankini and the top does not meet the bottom, you will not be permitted to wear it. If your mid section shows at all, you will not be permitted to join the group at the beach. No exceptions.
6. Attn: Men and young men, proper attire for the beach as well as your daily dress is that your shorts are never permitted to show your undergarments. If you go to the beach without proper attire and your undergarments show, you will not be permitted to swim.
7. Daily attire: If your shorts fall down to where your undergarments show, you will not be permitted to minister with the team. No exceptions.
8. The possession and use of alcohol, firearms, fireworks, tobacco, illegal drugs or pornography is prohibited at all times. Such items will be confiscated and the owner sent home.
9. Except for medical personnel, all participants are expected to dress appropriately for Dominican culture. Never forget: We are representatives of Christ. Except during construction work or at the Ministry Center, ladies need to wear skirts or a long dress whose hem falls at or below the knee. Comfortable modest dress, shorts, sundresses, pants, etc., for ladies at the Ministry Center ONLY is fine. When traveling to and from the Dominican Republic, comfortable modest attire is appropriate. Ladies arriving in conservatively designed pants is no problem.
